There are two semesters and four terms per year. The Boarding Fee is additional to the Tuition Fee for the year(s) enrolled. The Boarding Fee includes all meals, all laundry, mending of clothes and the supply of bed covers. Students are required to supply their own bed linen, blankets, pillows and towels.

This fee is non-refundable.

Overseas student bond

Years 7–12: **\$12710**

In addition to fees as per schedule, all overseas students are to lodge a bond of \$12710 (Yrs 7-12) within three weeks of offer of acceptance of enrolment being made before enrolment will be confirmed or by 30 September in the year prior to the student commencing studies at the School, whichever is the later. Bond will be refunded when the course of studies is completed. Payment of the Overseas Student Bond is in lieu of paying a Confirmation Fee.

Re-Booking Fee

, all continuing students: **\$100**

The Re-booking Fee is charged to each student's second semester fees and is credited towards the first semester fees in the following year. Payment confirms the student's place for the following year. This charge is not applicable to Year 12 students OR to those families who have advised the School (with sufficient notice) that the child(ren) will not be returning to the School in the following year. The fee is forfeited if sufficient notice of withdrawal has not been given. Interest is not paid on Booking and Re-booking Fees or the Overseas Student Bond.

Miscellaneous fees

Sundry Expenses Levy

Years 7–12: **\$157 per year**

This levy covers such items as Student Insurance, School Diary, most local excursions, School Magazine, class reference books, academic competitions, sports buses (Primary School), student ID cards.

Technology Levy

Years 7–12: **\$210 per semester**

This levy is to assist the School with the increasing cost of technology across the whole School.

Class Set Levy

Years 7–12: **\$30/semester; \$60/year**

The Class Set Levy covers replacement and purchase of class set books in English and other subjects where books are used for short periods of time. Students will still need to purchase the main textbook for most subjects. The levy is charged to accounts each semester.

Special (optional) subject fees

Music: Individual instrumental, theory or voice tuition is available through the School. This individual tuition is not however included as part of the School's music subject programme. General music studies are offered as part of the School's curriculum (see Courses and Electives List).

Extra individual music tuition

Years 7–12: **\$860/semester, \$1720/year**

Remedial/Learning Support

A Learning Support programme for English and Maths operates through the Secondary School at the Learning Enrichment Centre.

6x 40 minute lessons per week	\$4020 per semester

ESL (English as a Second Language)

Language support is offered on a "user pays" system. We recommend 6 periods per week of intensive language tuition.

ESL Fee: **\$3945** per semester/**\$7890** per year

IMPORTANT INFORMATION

Other Costs include:

- The School uniform
- Textbooks and stationery
- Miscellaneous costs, i.e. School photographs, School excursions and membership fees of various sporting clubs.

Payment: The fees of overseas students are to be paid in advance in two instalments, once per semester. If fees are outstanding, students will not be allowed to commence a new term unless a reason for non-payment has been given in writing and accepted by the Board Secretary.

Withdrawal: Parents wishing to withdraw their child(ren) from the School and/or the Boarding House(s) must inform the Headmaster in writing, giving one term's notice. Fees will be charged for one half term in lieu of required notice. If a student is asked to leave the School, that semester's fee will be forfeited.

Please note that Australian Government regulations for entry into Australia as an Overseas Student must be met.
